**Office Memorandum**


“ Entrepreneurship Skill Development Programme (ESDP)” a component of main scheme on the vertical of :Development of MSMEs (Entrepreneurship and Skill Development Programme) which had been approved by Hon’ble Minister of Ministry of Micro, Small and Medium Enterprises. The approved Scheme guideline was enforced w.e.f. 25.03.2022. The objective of the programme is to motivate youth representing different sections of the society including SC/ST/Women, Differently abled, Ex-servicemen and BPL person to consider self employment or entrepreneurship as one of the career options. The ultimate objective is to promote new enterprises, capacity building of the existing MSMEs and inculcating entrepreneurial culture in the country.

In this regard, provision for Agniveer by amending in the guidelines through shall be as under:-

Provision for Agniveer, “Under each of the five scheme components, 10% trainees seat would be reserved for those participants who have rendered four years of service as Agniveers subject to the availability of the candidates”.

This supersedes the earlier O.M. of even no. dated 10.10.2022 on the subject.
